### Evening Meeting at Addleshaw Goddard: Monday 22 February, 2016 at 6.00 pm

The CLA will be holding an evening meeting on **Monday 22 February** at **Addleshaw Goddard LLP**, 60 Chiswell St, London, London EC1Y 4AG. Registration for the event will start at 6pm followed by the lecture at 6:15pm.

**Iain Morley QC, Mukul Chawla QC and Gillian Jones** have kindly agreed to speak on the following subject:

#### “Criminalising anti-competitive behaviour: cartel offence or conspiracy?”

**Iain Morley QC**, 23 Essex Street Chambers is an experienced advocate whose practice encompasses both domestic and international criminal law, with emphasis on homicide (murder, manslaughter, genocide), and upon complex casework, including fraud. Since 2004, Iain has become a well-known figure on the international circuit, practising in genocide, war crimes, crimes against humanity, and international terrorism. He represented Clive Dean in the CMA's prosecution of the criminal cartel offence in the galvanised steel water tanks case.

**Mukul Chawla QC**, is a specialist criminal and regulatory QC handling cases of the greatest complexity. In crime, he has experience in prosecuting and defending the most serious offences of fraud, corruption and allegations of insider dealing. He advises companies and individuals in a wide range of criminal and regulatory matters including Financial Services, compliance with the Bribery Act 2010, privacy issues and export and trade control compliance. He is leading counsel for the SFO in the first prosecution internationally in respect of the alleged manipulation of the London Interbank Offered Rate ("**LIBOR**").

**Gillian Jones**, Red Lion Chambers has developed a specialism in Financial Services Regulation. She was instructed as the first junior in the Financial Conduct Authority's ("FCA") flagship prosecution of an insider dealing ring and is currently instructed by the SFO as junior prosecution counsel in the "LIBOR" case. As part of her advisory work, Gillian advises City Law firms in respect of corporate compliance and governance issues.
