Tanya Aplin is a Professor of Intellectual Property Law at the Dickson Poon School of Law, King's College London. She is also Vice-Dean for Research in the Law School, Director of the Postgraduate Diploma in UK, EU and US Copyright Law and Director of the LLM in Intellectual Property and Information Law. Her publications include: Gurry on Breach of Confidence: The Protection of Confidential Information (OUP, 2012) (with Prof. Bently, Dr Johnson and Mr Malynicz) and Copyright law in the digital society: the challenges of multimedia (Hart, 2005), Intellectual Property: Patents, Copyright, Trade Marks and Allied Rights 7th and 8th eds (Sweet & Maxwell, 2010, 2013) (with Prof. Cornish and Prof. Llewelyn), Intellectual Property Law: Text, Cases and Materials 1st, 2nd and 3rd eds (OUP, 2009, 2013, 2016) (with Dr Davis). She teaches courses on comparative copyright law and EU and UK patent and trade secrets law.
