"Recent Developments in Private Actions: the perspective from the UK, Netherlands and France"

Muriel Chagny (Moderator) is a Law Professor at the Paris-Saclay University in France where she is director of the Competition and Contract Law Masters. She teaches Competition Law, particularly in conjunction with contract and tort law with a focus on new technologies, and also French and European contract law. She is General Rapporteur of AFEC. She was appointed as a member of the Commission in charge of examining commercial practices in 2013 and renewed in 2016. She has recently written a book on Competition damages resulting from infringements of Competition Law.

Elizabeth Jordan is a Counsel at Linklaters LLP within its Competition Litigation team. She has wideranging experience advising corporates and financial institutions on contentious matters, particularly in relation to competition and EU law issues. Elizabeth has extensive experience in the conduct of competition litigation before both the English High Court and Competition Appeal Tribunal. She also regularly advises clients in connection with competition investigations.
