**Spyros Maniatis** is Professor of Intellectual Property and Director of the Centre for Commercial Law Studies at Queen Mary University of London. He is co-author of "Trade Marks, Trade Names, and Unfair Competition World Law and Practice" and "Trade Marks in Europe: a Practical Jurisprudence".

**Alastair Mackay** is Corporate Affairs Manager for Philip Morris International (PMI) in the UK. Since joining PMI in 2013 he has represented the company on a range of fiscal and regulatory issues. Earlier in his career he spent several years practising as a solicitor in London and Brussels, specialising in competition law.

**Jonathan Griffiths** is a Reader in Intellectual Property Law at Queen Mary University. He specialises in intellectual property law (particularly copyright law) and information law. He has published widely on comparative copyright law and on the relationship between intellectual property and fundamental rights. He is currently working on projects on the Court of Justice of the European Union's development of copyright law and on plain packaging legislation and the concept of expropriation.
