### "Competition law and procurement in the healthcare sector: recent developments"

**Jonathan Blackburn** heads the team of lawyers which supports Monitor's competition related functions. Before joining Monitor Jonathan was Legal Director at the Cooperation and Competition Panel since January 2012. Jonathan came to the health sector from the Competition Commission where he spent 5 years advising on merger inquiries and market investigations in a wide range of industries. Before that Jonathan spent 10 years at a City law firm in the EU, Competition and Regulatory team. He spent a year on secondment to Ofcom in 2004.

**Alastair Mordaunt** is a partner at Clifford Chance specialising in UK and Competition Law, in particular mergers and acquisitions, joint ventures, cartels and abuses of market power across a wide range of industry sectors. Alastair joined Clifford Chance from the Office of Fair Trading where he was Director of a dedicated competition enforcement team and previously Director of Mergers. Before joining the OFT, Alastair spent several years in private practice advising on merger and antitrust matters before the UK, EU and US antitrust authorities.
