LIDC Questions Workshop: Thursday 19 May, 2016 at 6pm – PLEASE NOTE CHANGE OF DATE

Every year the LIDC examines two topical questions concerning competition law and the law against unfair competition.

This year the competition law question (question A) relates to the application of the competition rules in the pharmaceuticals sector.

The IP/unfair competition question (question B) considers the rules for claims by suppliers of goods or services about national or geographical origin of their goods or services.

Details of the two questions for 2016 are detailed below.

We are pleased to announce that our two national reporters this year are James Bourke, Monckton Chambers (on question A) and Ashley Roughton, Nabarro (on question B). The National Reporter for each question is responsible for preparing a report dealing with questions raised by the relevant International Reporter and representing the views of the national group. Based on the various national reports, the International Reporter for that question then prepares an international report, including, where possible, a draft of a Resolution.

The purpose of the Workshops is to seek Members' contributions and comments on the draft UK reports prepared by our National Reporters that will be circulated in advance. This will include input into the issues of policy and principle underpinning each question and any Resolution which the Association considers should be proposed.

The Workshop will be held on **Thursday 19 May at Monckton Chambers**, 1 & 2 Raymond Buildings, Grays Inn, London WC1R 5NR. The working session will begin at **6.00pm** and will last for up to two hours. The Workshop is informal and refreshments will be on offer to lubricate discussions.

There is no additional charge for members. There will be a charge for non-members: £50, or £35 (full time academic/public sector employees), or £10 (student, trainees, pupil barristers). Registrations can be completed and paid for on-line. Two CPD points will be available.
