will deliver a lecture on:

“Revolution without end? A politician’s view of Brexit”

As Brexit discussions develop at pace, we will hear the latest thinking from a parliamentarian playing a front-line role from the back benches.

Dominic Grieve QC MP is a barrister and has been the MP for Beaconsfield since 1997. He was the Shadow Attorney General from 2003-09, Shadow Home Secretary from 2008-09 and Shadow Justice Secretary from 2009-10. Under the Coalition Government he was the Attorney General for England and Wales and the Advocate General for Northern Ireland until July 2014.

Dominic Grieve was educated at Westminster School and Magdalen College, Oxford where he studied Modern History. Then he studied Law. He was called to the Bar in 1980 and was appointed a Queen’s Counsel in 2008. He is a bencher of the Middle Temple. During the 1980s, he served as a local councillor in Fulham. He was Chairman of the Research Committee of the Society of Conservative Lawyers between 1992 and 1997 and was elected Chairman of the Intelligence and Security Committee in September 2015.
