The CLA will be holding a lunchtime webinar on **Friday 25 June** from 12.00 to 1.00pm.

David Bailey has kindly agreed to speak on the following subject:

“Navigating competition law issues in IP settlements”

Professor David Bailey of Brick Court Chambers will discuss the recent judgments of the Court of Justice in Lundbeck and Generics UK and the Competition Appeal Tribunal’s final judgment in the appeals against the CMA’s Paroxetine decision. David’s talk will look both at the legal principles established in these judgments and their practical implications for settling IP litigation.

David Bailey is a practising Barrister at Brick Court Chambers. David is Standing Counsel to the UK Competition and Markets Authority and to the Hong Kong Competition Commission. David is a Professor of Practice in Competition Law at King’s College London, where he also teaches on the LLM programme. David is the co-author (with Richard Whish) of the tenth edition of *Competition Law*, which will be published in August 2021.
