### Evening Webinar: Wednesday 14 July 2021 at 5.30 pm

The 2021 Annual General Meeting of the Association will be held remotely via Zoom on Wednesday 14 July 2021.

The AGM is being held in conjunction with a talk – Sir Christopher Bellamy QC has kindly agreed to speak on the following subject:

### **“Modern Competition Law: where next post-Brexit?”**

**Sir Christopher Bellamy** QC, Monckton Chambers. Sir Christopher specialises in European, competition and regulatory law, and became a QC in 1986. In 1992, he was appointed as a judge to (what is now) the General Court of the European Union where he served for 7 years. At the end of 1999, he returned to the UK to set up the Competition Appeal Tribunal (CAT), of which he was President until 2007 when he retired. He became a senior consultant with Linklaters LLP and Chairman of the Linklaters' Global Competition Practice in 2011. He stepped down from Linklaters at the end of October 2020 and re-joined Monckton Chambers. Sir Christopher focusses on appointments as a mediator or arbitrator in disputes including but not limited to competition and international regulatory matters.

The talk will be followed by a presentation by Sir Christopher, in his role as UK National Rapporteur and in advance of the LIDC Congress which is taking place in Brussels 23-25 September 2021, to discuss his draft LIDC report on the following subject:

### ***“What is the role of antitrust authorities regarding the digital economy?”***

The report will form part of the discussions at the Congress with a view to adopting resolutions in the areas concerned. A copy of the report will be circulated along with the joining instructions.
