The CLA will be holding a lunchtime webinar on **Tuesday 5 October** from 12.30 to 1.30 pm.

Sarah Aitchison has kindly agreed to speak on the following subject:

“Competition Policy Update: Competition and Consumer Policy Reform”

*In July this year, the government published a **consultation** on proposed reforms to competition and consumer regimes. The proposals seek to:*

- promote competition to drive enterprise, innovation, growth, and productivity;*
- update consumer rights to keep pace with markets; and*
- strengthen the enforcement of consumer law by individuals and regulators.*

Sarah Aitchison, Assistant Director in the CMA's Policy and International team, will highlight some of the reforms which will be followed by a discussion of the proposals.

Sarah Aitchison has worked in the CMA's Policy and International team leading on various areas of competition and cross-cutting policy for the past six years, most recently relating to settlement and penalties and inputting into the CMA's work on the reform proposals. Prior to this, Sarah spent around 15 years working in various consumer and competition enforcement teams across the CMA and the OFT. Sarah is based in the CMA's Edinburgh Office.
