SPEAKERS

John McInnes is a Senior Legal Director at the CMA. He is responsible for the CMA's policy and international team and also provides senior input on the work of the CMA's Digital Markets Unit. Before joining the CMA, John spent time working as a competition lawyer in private practice and at Ofcom.

Peter Schedereit has been a case handler at the European Commission's Directorate General for Competition (DG COMP) since 2016. In 2021 he joined Unit E1, dealing with antitrust matters in the pharma and health services sectors. He is also involved in the ongoing evaluation of Regulation 1/2003, i.e. the current procedural framework for the application of EU antitrust rules. Previous to that, he worked on antitrust cases in the semiconductor sector, including the Broadcom interim measures case and the Qualcomm predation case. Prior to joining the European Commission, Peter also spent some time in private practice in Italy, Germany and Brussels.

Prof. em. Dr. Jacques Steenbergen is the former President of the Belgian Competition Authority. Prior to this he was Director General of the directorate general for competition at the Belgian Ministry of Economic Affairs. He taught competition law at the University of Leuven from 1980 to 2014. Before joining the Competition Authority, he was a partner in the Brussels office of Allen & Overy and has been the legal secretary to the President of the Court of Justice.
