Evening Meeting and AGM: Wednesday 27 September 2023 at 6:00 pm

The CLA will be holding an evening meeting on **Wednesday 27 September** at Herbert Smith Freehills, Exchange House, Primrose Street London EC2A 2HS. This is being held in conjunction with our **Annual General Meeting**. Registration will open at 5:45pm, the AGM will begin promptly at 6:00pm followed by the talk at 6:15pm.

Matthew Byford, Josh Holmes KC and **Helen Fairhead** have kindly agreed to speak on the following:

“Costly conversations – a review of recent developments in competition law applying to information exchange”

The panel moderated by Kim Dietzel will consider Ofcom's Motorola/Sepura infringement decision dealing with a 'costly conversation', as well as the information exchange issues that featured in the Phones4U trial. It will also touch on the amended EU Horizontal Guidelines (with their revised chapter on information exchange, which expands on a range of concepts and types of information sharing including hub-and-spoke arrangements, public announcements, data sharing and collaboration through algorithms), asking itself the question at what point transparency tips into anti-competitive information exchange.

Matthew Byford is a principal legal advisor at Ofcom. He was the lead legal advisor on Ofcom's recent decision to fine Sepura for sharing competitively sensitive pricing information with Motorola in the context of a tender process. He has previously advised on competition and regulatory law matters at Openreach and in private practice.
