James Killick and **Michael Silverleaf** have kindly agreed to speak on the following subject:

"Flynn Pharma and Pfizer: the IP and competition aspects of Phenytoin Sodium Flynn"

James Killick is a Partner at White and Case, based in Brussels. He regularly advises leading pharmaceutical multinationals and the major US and EU industry pharmaceutical associations on EU and national law and policy affecting the pharmaceuticals sector, notably in areas such as standard setting, where IP and competition law overlap. His practice covers licensing and distribution issues, regulatory matters, intellectual property, data protection, and national implementation of EU measures, notably on pricing and reimbursement. He has been involved in pleading a number of leading cases in the European Courts, including *Microsoft v Commission* (compulsory licensing; treatment of trade secrets), *Hanner* (Swedish retail monopoly on pharmaceuticals), *Pfizer v Council* (precautionary principle), *IMS Health* (compulsory licensing), and *Servier v Commission* (banning of pharmaceuticals). He was actively involved in the European Commission's pharmaceutical sector inquiry, representing a major global company.

Michael Silverleaf is a Barrister at 11 South Square. Before joining the Bar in 1980, Michael read physics at Imperial College. Since his appointment as Queens Counsel in 1996 he has become one of the leading IP Silks. He has appeared in many leading patent, trade mark and copyright cases and is noted for his technical grasp and IP expertise. He is also well-known for his IT practice, having acted in a number of substantial IT disputes.
